

• India's coal production increased by 11.83% to 96.60 MT from 86.38 MT during Feb'24 as compared to Feb'23. During Feb'24, CIL, SCCL and Captives/Others registered a growth of 8.69%, 6.54% & 33.28% by producing 74.76 MT, 6.42 MT & 15.41 MT of coal respectively.

- India's coal despatch increased by 13.64% to 84.78 MT from 74.61 MT during Feb'24 as compared to Feb'23. During Feb'24, CIL and Captives/Others registered a growth of 12.05% & 31.10% by despatching 65.30 MT & 13.55 MT of coal respectively.
- The Power utilities despatch has increased by 5.68% to 72.18 MT during Jan'24 as compared to 68.30 MT during Jan'23.


## **Coking Coal Import Traffic at Indian Ports**







- Kandla port recorded highest traffic at 4.53 MT followed by Visakhapatnam Port at 2.35 MT.







# India reaches 1 bn tonne coal, lignite output target

India's coal sector achieved its target of producing 1 billion tonne of coal and lignite in fiscal year 2023-24, according to coal minister Pralhad Joshi. It had set a goal of over 1 billion tonne for the 2023-24 fiscal year, which it achieved a week before the year-end(FY24). However, demand is still projected to be about 1,196.6 million tonne (MT) this fiscal year. In FY 2022-23, the country's coal and lignite production reached 937.22 MT. "PM Narendra Modi ji is leading India's coal mining sector to unprecedented growth," Joshi said in a tweet. "PM Modi ji's vision has brought everyone together to achieve 1 billion tonne production of coal+lignite. With this, we have unlocked a major milestone for the coal mining sector, thereby assuring energy security to the nation."

The country boasts a substantial coal stockpile, with about 96 MT available with coal companies. Additionally, domestic coal-based thermal power plants maintain coal stocks of 46.25 MT as of March 20, 2024. As electricity demand is expected to double by 2030, and coal remains a major source of energy, accounting for 55% of India's needs, the government is committed to increasing its production. A plan to achieve 1 billion tonne (BT) coal output by 2023-24 and for Coal India to reach 1 BT by 2024-25 has already been prepared. All India production reached 778.21 MT in 2021-22 and rose to 893.19 MT in 2022-23, reflecting a positive growth of 14.77%.

As per coal ministry data, the government is making strides to reduce coal imports. This fiscal year, imports reached 200.23 MT, compared to 237.67 MT last year. The country mainly imports coking coal for the steel sector to bridge the gap between domestic availability and meet quality requirements. Other sectors, such as power, cement, and coal traders, import non-coking coal. The ministry, in a statement, said achieving 1 BT in coal and lignite production will ensure homes remain lit even as the coal sector continues to power the economy.




# By 2030, coal companies to up renewable energy capacity to over 9 GW

- The coal sector is set to ramp up renewable energy capacity to over 9 GW by 2030, from the current 1.7 GW, the coal ministry said on Tuesday. The ministry is actively promoting the deployment of both rooftop solar and ground-mounted solar projects across mining facilities. Plans are underway to develop solar parks within the reclaimed mining areas and otherwise, the ministry said. Currently, a combined solar capacity of 1.7 GW has been installed by coal companies, including CoalIndia, NLC India, and Singareni Collieries Company Ltd.
- Coal auctions JK Cement has won the Mahan coal mine in Madhya Pradesh in the latest forward auction of commercial coal mines. Rungta Sons Pvt Ltd pipped JSW Steel Ltd to clinch South of Damuda in Jharkhand. Bull Mining won Jharkhand's Duni Central, where Tata Steel was also a contender, according to the data available from the coal ministry.

# Coal imports surge, exceeding FY23 shipments amidst rising power demand

- India expect power demand to grow at 6-7 per cent y-o-y due to increasing consumption from industries and households.
- Power consumption, anticipating peak demand to reach 255 gigawatts (GW) during April-June 2024.
- The overall imports for April-February in FY24 reached 163.40 mt, reflecting a y-o-y growth of 11 per cent over the same period in FY23.
